bodycur and MEDEC will corporate in Germany

04. 07. 2005 – Perth based health care equipment company MEDEC Limited [ASX: MAA] has signed a Heads of Agreement with bodycur of Germany to promote MEDEC's Health Center System in Germany. bodycur operates 33 Health Centers in Germany on a franchise basis, offering a unique concept of health, diet and slimming advice. Additionally to providing a healthy, nutritional and well tasting diet designed by one of Germany's well known chefs some 25 German top restaurants offer bodycur's nutrition as part of their menu, allowing bodycur clients to also eat out in style while maintaining their diet objectives.

In May 2005 MEDEC has launched its Hight Tech computer supported Biograph metabolic assessment device, which is ideally suited to give personalised advice regarding what type and balance of food to eat and in what quantity. The Biograph Calori-Fit provides information of how different people metabolise the food which they eat into energy and how this energy is provided for the challenges of life. This is of interest to every person but particularly for people which want to loose weight and improve body texture at the same time.

MEDEC has developed its MEDEC Health Center concept, which uses the Biograph to provide information on what type of food to eat or not to eat. The MEDEC Health Center also supplies MEDEC's space age bio-stimulation and detoxification devices. MEDEC clients benefit from a higher metabolic rate, better fat burning capabilities giving more energy, better self healing and more quality of life.

bodycur and MEDEC have now finalised an agreement, under which bodycur will adopt the MEDEC Health Center concept within its franchise system. bodycur plans to introduce the MEDEC Health Center concept to its 33 franchisees and eventually to its 30,000 clients. By using the MEDEC technology bodycur becomes the first German nutritional company which uses diagnostic instrument in the giving personal nutritional advice.

The project will be rolled out stages. During July – November 2005 bodycur and MEDEC will establish 2 training centres in Germany and further franchisees will then be supplied and trained during the 4th Quarter 2005. Hardware leasing and software licensing will be provided by the corporation partners. MEDEC has organised product supply and after sales service via its German subsidiary. An online training program is presently prepared by RMIT university of Melbourne, Australia's oldest and largest university.

With this project, MEDEC's order book for the new Biograph Calori-Fit device has increased to 150 units to be supplied within the next 4 month. Further negotiations are held with German companies to introduce the MEDEC technology to the German fitness industry, where the Biograph Calori-Fit can be used to design an individual training program to maximise fat burning by assessment of the individuals metabolic rate and training progress.
